

EMERGENCY PROCEDURES

Safety is a primary issue when planning Scouting activities. The **Guide to Safe Scouting** can help you plan a safe Scouting event. The following procedures are in place for council staff and volunteers. Their primary focus is on getting swift aid to the individual and making proper notifications and collecting necessary information.

PROCEDURES FOR MEDICAL EMERGENCY or SERIOUS ACCIDENT/FATALITY

1. Seek medical help through the camp leadership, by calling 911, or other means as necessary.
2. Notify Camp Ranger or Camp Director (if occurs at council camp.)
3. Notify either the Scout Executive or Camp Director if it is a serious accident or injury.
4. Parents should be notified through a designated council staff member when the injury is serious.
5. **Collect all information if medical care is required and submit an *Accident Report Form* to the Program Department within 2 days via fax - 715-355-9849 or mail to Samoset Council, BSA, 3511 Camp Phillips Road, Weston, WI 54476.**
6. The Scout Executive will be the public voice if needed.

YOUTH PROTECTION

Note: You are now asked to report to local authorities followed by reporting to the Scout Executive:

Mandatory Report of Child Abuse:

All persons involved in Scouting shall report to local authorities any good faith suspicion or belief that any child is or has been physically or sexually abused, physically or emotionally neglected, exposed to any form of violence or threat, exposed to any form of sexual exploitation including the possession, manufacture, or distribution of child pornography, online solicitation, enticement, or showing of obscene material. No person may abdicate this reporting responsibility to any other person.

Notify your Scout executive of this report, or of any violation of BSA's Youth Protection policies, so that he or she may take appropriate action for the safety of our Scouts, make appropriate notifications, and follow-up with investigating agencies.

The directory to the right lists the telephone contact for each county within Samoset Council. Those reporting a suspicious case of child abuse are to call the county where the incident allegedly occurred.

* The costs for ambulance, doctors, and hospitals are a responsibility of the parent. The council does provide limited, secondary accident insurance for its members while they are participating in Scout activities. A report must be filed for all accidents or injuries requiring medical attention.

INCIDENT REPORTING - (Fights and Altercations - Non-Medical Incidents)

1. Notify Camp Ranger or Camp Director (if occurs at a council camp).
2. Notify Scout Executive (if outside of council property).
3. Collect all information and submit an *Incident Report Form*.
4. The Scout Executive will be the public voice if needed.
